**BOND** – Every applicant who intends to take sales orders and down payments for the later delivery of goods and services and is not a resident of Ozaukee County Wisconsin, or who is such a resident and represents a business or organization whose principal place of business is located outside the State of Wisconsin, shall file with the Clerk a surety bond for a term of one (1) year from the date of issuance of license, running to the City in the amount of Five Thousand Dollars (\$5,000.00) with surety acceptable to the Mayor, conditioned that the applicant comply with all applicable ordinances of this City and Statutes of the State of Wisconsin regulating peddlers, canvassers, solicitors and transient merchants. Such bond shall guarantee to any citizen of this City that all money paid as a down payment will be accounted for and applied according to the representations of the seller and that the property purchased will be delivered according to the representations of the seller.

<u>APPLICATION FEE</u> - No application shall be processed until the following fee has been paid to the Clerk: Residents of City or Organization represented by applicant which has been conducting its business activities in the City for one year prior to application - \$100 annually. All other applicants \$150 annually. An annual fee of \$10 shall be paid for each additional direct seller within the organization. License is valid for calendar year.
